What will you be selling at the event (i.e. Food, Jewelry, Insurance, etc.)?

The Fresno Night Market is owned and operated by AK Events and sponsored by the ReZCom Network. This Exhibit Space Contract for the Fresno Night Market is subject to the terms and conditions set forth below. This Contract is not valid until signed by both parties.

EXHIBIT SPACE ASSIGNMENTS: Exhibitor agrees to complete and submit this contract prior to the event. Full payment must be received with the contract unless prior arrangements are made with AK Events. Booth spaces and food truck slots will be determined and assigned by AK Events. Food trucks and expo booths will be assigned in a designated area.

EXHIBIT: Business exhibitors must provide their own 10x10 pop-up tent, table, table-covering and chairs. **THERE WILL BE NO ELECTRICITY PROVIDED TO BUSINESS BOOTHS.** No gas generators are allowed except in a food truck. We suggest using charged or battery-operated generators. We recommend bringing your own lighting to illuminate the inside of your pop-up tent to give it a unique look. We will have light towers throughout the venue. No propane

lanterns will be allowed. AK Events reserves the sole right to judge the appropriateness of the display, products, services and literature promoted by Exhibitor and to prohibit the sale or display of any product or service deemed inappropriate by AK Events. Exhibitor agrees not to claim or represent either orally or in writing, that any product or service exhibited at or during the event is endorsed or approved by AK Events.

EXHIBIT BOOTHS: Exhibitor agrees to be completely set up by 3:00p prior to the event opening and staff the booth or food truck during the expo. Exhibitor shall not use pop-up shades or tents unless approved by AK Events. Exhibitor shall not display, advertise, sell or otherwise promote any product or service outside the confines of the assigned booth space or food truck slot in the event area or outside of the exhibit area during the duration of the event. Exhibitor shall not dismantle booth or close food truck prior to the ending of the event at 9:00p. Exhibitor agrees to dismantle booth or close food truck as soon as possible after the event by 10:00p. Any items left in the booth space or food truck slot will be considered abandoned.

FOOD TRUCKS: Food truck exhibitors must complete the attached County of Fresno Community Event Food Vendor Application and submit to AK Events with this contract. Food truck exhibitors must be compliant with all County of Fresno food truck regulations. Non-compliance will result in being prohibited from exhibiting and no refund will be issued. If you have questions on food truck compliance, contact the County of Fresno Department of Public Health, (559) 600-3357.

RAFFLE PRIZE: Booth exhibitors are requested to bring a raffle prize of no less than \$25.00 in value to give away at the event. Exhibitors will conduct their own raffle. Food trucks do not need to provide a raffle prize.

FIRE REGULATIONS: Exhibitor agrees to adhere to all regulations and fire codes as dictated by the venue and the City of Fresno Fire Department. No fire lanes or hydrants may be blocked.

INDEMNIFICATION: Exhibitor agrees to hold AK Events and ReZCom Network, its owners, officers, agents, contractors and volunteers free and harmless of and from, and defend and indemnify them against all liability, loss, damage, expense, costs (including without limitation attorney fees, costs and other fees of litigation) of every nature, including but not limited to any third party claim, arising out of any alleged negligent act or omission of the Exhibitor, its agents, officers, employees, representatives, servants, invitees, patrons or guests, except such loss or damage which is caused solely by the active negligence of AK Events and ReZCom Network. Exhibitor further agrees to hold AK Events and ReZCom Network, its owners, officers, agents, contractors and volunteers free and harmless of and from any and all liability, loss, damage, expense, costs (including without limitation costs and fees of litigation) of every nature arising out of any alleged loss or damage of any and all exhibit materials supplied by Exhibitor.

INSURANCE: Food exhibitors and business exhibitors that are exhibiting with vehicles must maintain business and auto insurance to cover against any and all damage and loss that arise due to the negligence of the Exhibitor during the event.

CANCELLATION: No refunds will be issued for any reason.

SECURITY will be present during set up and during the event. Security is provided as an accommodation for the Exhibitor and AK Events assumes no responsibility for lost, stolen or damaged property of the Exhibitor.

If AK Events should be prevented from conducting the event due to any cause beyond its control, including, but not limited to, strike, fire, civil disobedience, inclement weather, lock outs, acts of God, terrorism or terrorist acts whether actual or threatened, acts of a public enemy, epidemics or quarantines, or other causes, acts, or events similar to those enumerated, venue cancellation, city/county prohibition, AK Events will reschedule the event and notify the Exhibitor. All amounts paid by the Exhibitor will be credited towards the rescheduled event. No refunds will be issued.
